SUBJECT	Agenda Item #6: Review and Discussion of Examination Sequencing and Timeline Scenarios That May Affect Applicants and the Board's Business Processes Relating to EPPP2 Implementation		

### **Background:**

At the last EPPP2 Task Force meeting held on April 5, 2018, Mr. Seyron Foo (Board member) requested a diagram of each possible option available to the Board in implementing the EPPP Part 2 Exam. These options are included in the following attachments:

- Attachment A: Overview of the Current Examination Qualification for the EPPP
- Attachment B: Overview of EPPP Examination Process as of 1/1/2020 without changes to the Regulations (Option 1) – This option would prevent pre-degree application to ASPPB and the possibility that examination results for applicants who have taken the EPPP part 1 in another state could be invalidated if it was taken prior to degree completion.
- Attachment C: Overview of EPPP Examination Process as of 1/1/2020 with ASPPB Pre-Degree Application (Option 2) – This option allows pre-degree application directly to ASPPB for students from APA programs who have completed all academic coursework. This creates an unfair licensing process and market disadvantage for students who are in non-APA approved programs as it will extend the timeframe for completion of all licensure requirements for non-APA students and delays non-APA student's ability to start practicing professionally and earning professional wages, thus extending the time they will need to be paying for the associated student loans.
- Attachment D: Overview of EPPP Examination Process as of 1/1/2020 with Board Pre-Degree Application (Option 3) – This option allows pre-degree application for all students (APA and non-APA programs). This process is the most equitable solution for all applicants that also preserves the Board's ability to ensure all applicants meet the same eligibility requirements without undue delay or denial. Given the current direction of ASPPB, it is the recommendation of staff that Option 3 is the best solution available to the Board and applicants at this time.



Based on the action taken on Agenda Item #5, the Task Force should review and discuss the examination sequencing options provided and move to recommend one of the options to the Board.



## Attachment A: Overview of the Current Examination Qualification for the EPPP






## Attachment C: Overview of EPPP Examination Process as of 1/1/2020 with ASPPB Pre-Degree Application-(Option 2)
