SUBJECT	Applied Behavioral Analysis (ABA) Task Force: 16 (a)

Background:

At the May Board Meeting Board President Michael Erickson announced the creation of an ad hoc Task Force to review the developing field of Applied Behavioral Analysis. Board Staff were tasked with identifying prospective members and send out invitations to those individuals and organizations.

The goals of the Task Force are to determine whether the work performed by ABA practitioners falls under the Board's Practice Act, and if so, the Task Force would need to identify the scope of practice and most beneficial structure for the regulation of the ABA practitioners.

The Board of Psychology (Board) is creating a Task Force to explore the rapidly developing field of Applied Behavioral Analysis (ABA). The field of ABA practitioners has been in development for a number of years. The Task Force seeks to build upon the work already conducted by the Autism Advisory Task Force and work with practitioners and stakeholders to ensure safety for the consumers of Behavioral Health Treatment.

The goals of the Task Force are to determine whether the work performed by ABA practitioners is covered by the Board's Practice Act, and if so, the task force would need to identify the scope of practice and most beneficial regulatory structure for the regulation of ABA practitioners. The Task Force will meet on three or four occasions between September 2014 and February 2015 and report its finding to the Board of Psychology in May 2015.
