### **CE Audit Statistics:**

Please find attached the statistics (as of October 22, 2014) for the Continuing Education (CE) Audits for January 2013 through July of 2014.

Internal audits on CE submissions began due to a regulation change which was made effective January 1, 2013. Prior to internal audits being implemented, CE was monitored by the Mandatory Continuing Education for Psychologists Accrediting Agency (MCEPAA).

For the months of January through June (2013), approximately 5% (approximately 35 licensees per month) of the renewing licensees were selected for audit. Beginning with July (2013), approximately 10% (approximately 70 licensees) are being selected for inclusion in the audit.

More detailed information, including up-to-date statistics, will be provided during the Committee Meeting.





#### **Definitions:**
