CE Audit Statistics:

Please find attached the statistics (as of February 2, 2015) for the Continuing Education (CE) Audits for January through October of 2014.

Internal audits on CE submissions began due to a regulation change which was made effective January 1, 2013. Prior to internal audits being implemented, CE was monitored by the Mandatory Continuing Education for Psychologists Accrediting Agency (MCEPAA).

Approximately 10% (approximately 80 licensees) of renewing licensees are being selected for inclusion in the audit.

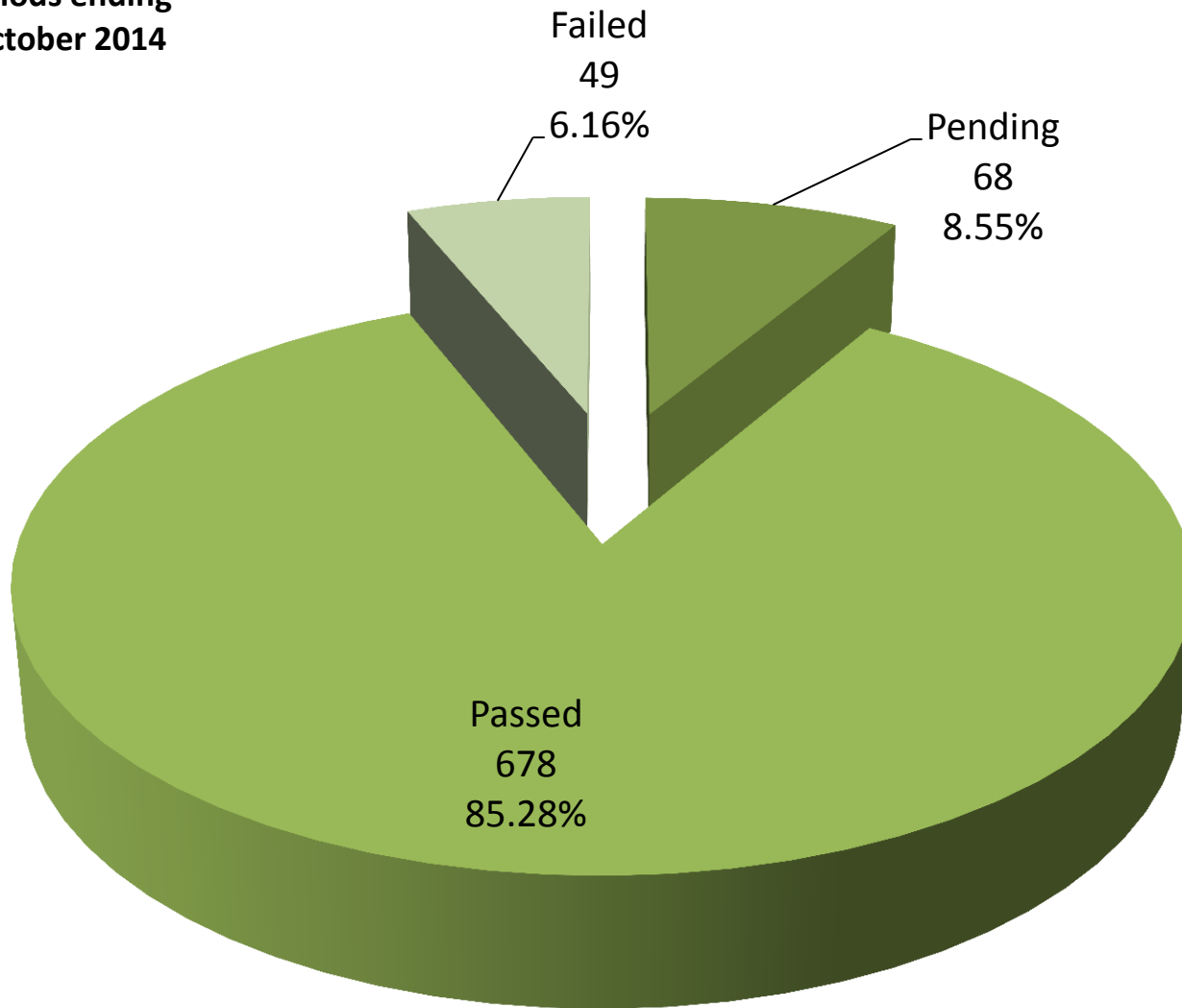

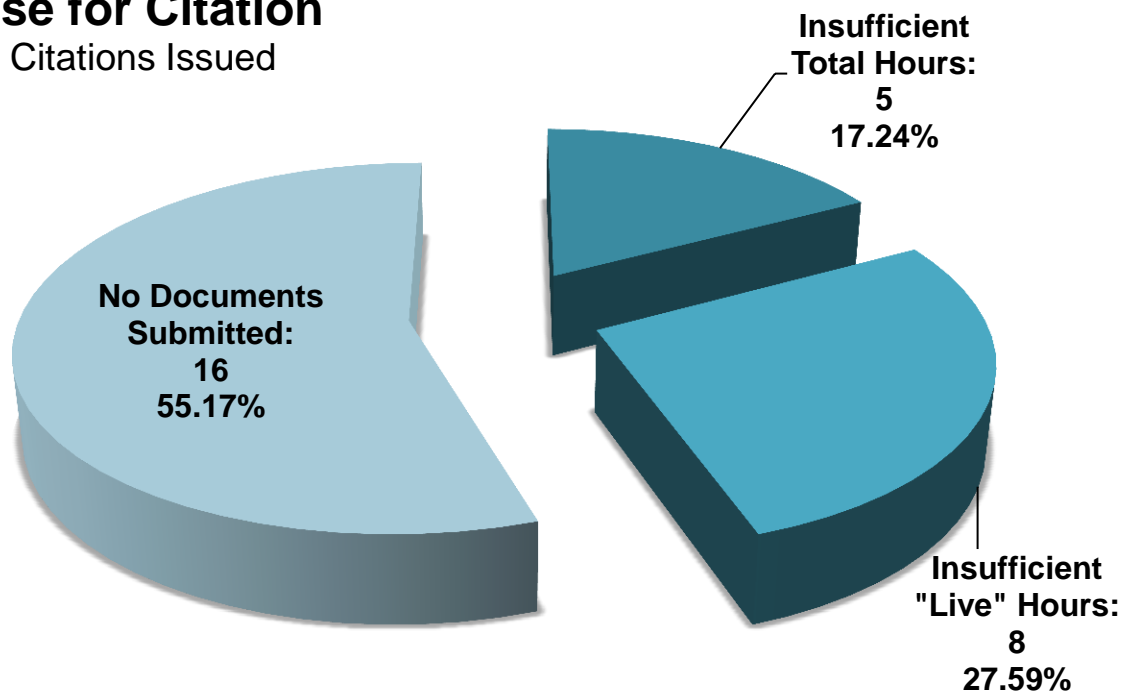

Definitions:

Live: As compared to "independent learning," where the instructor and student are not in direct visual or auditory contact. A minimum of nine (9) "live" hours are required per renewal cycle.

Abatement: Licensee has submitted documentation to come into compliance with the continuing education requirements.
