Approximately 10% (approximately 80 licensees) of renewing licensees are selected for inclusion in the audit each month.

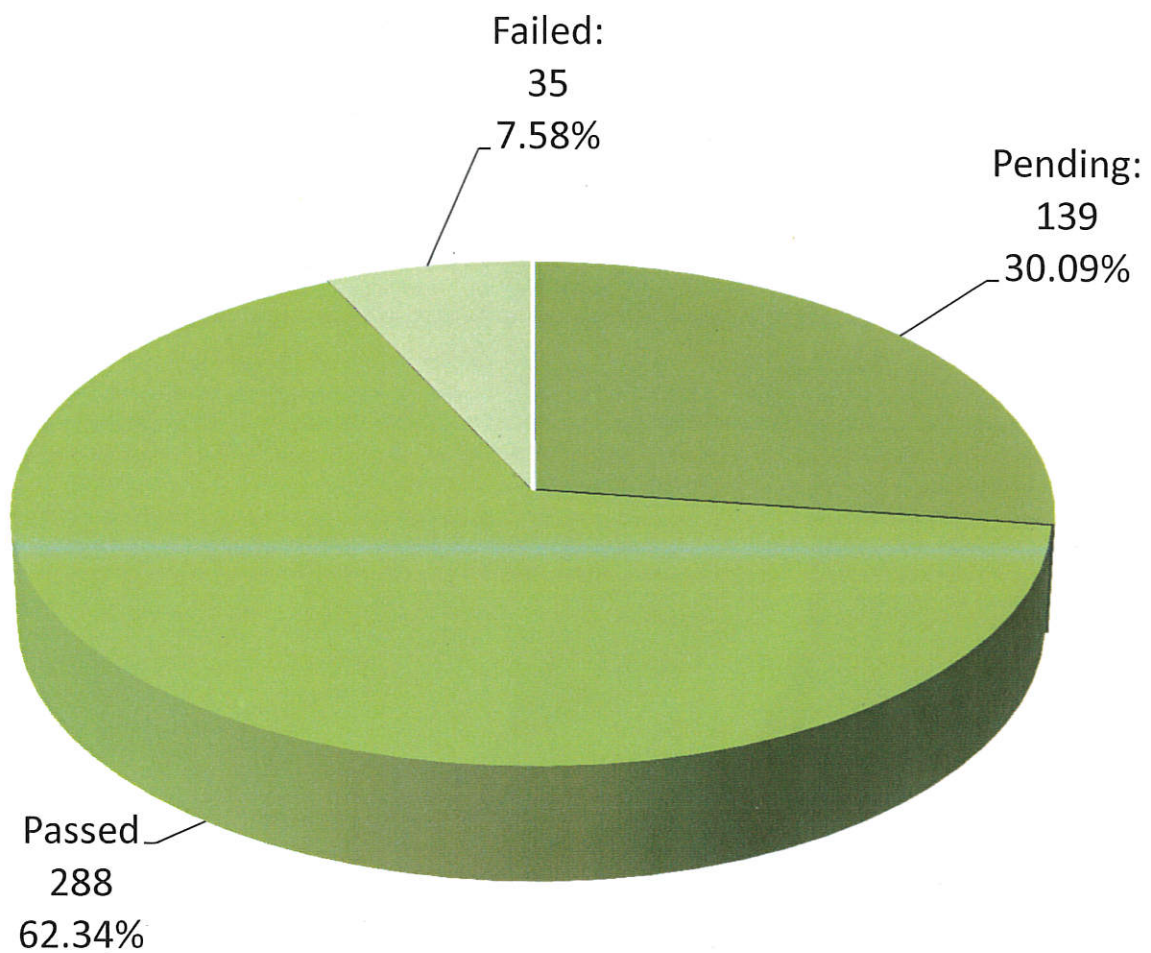

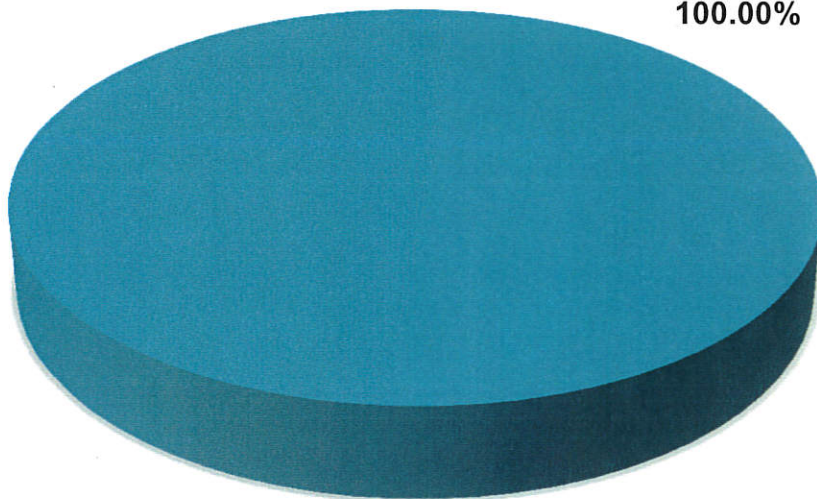

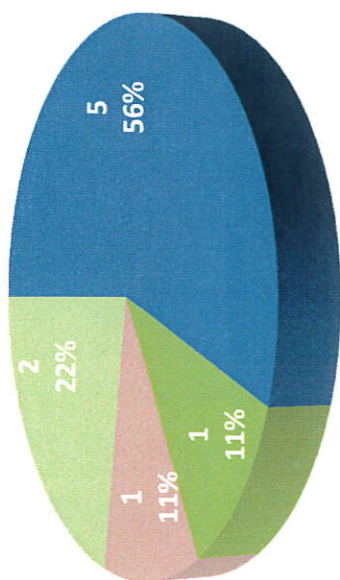


### Definitions:

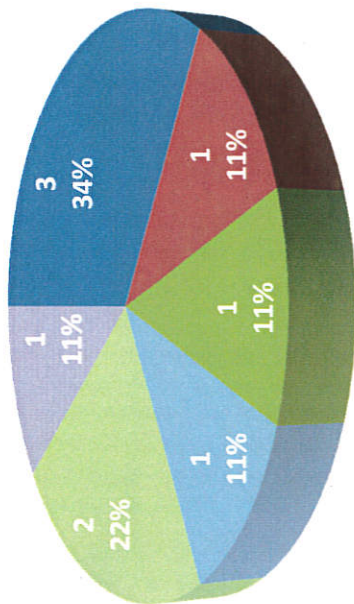
**Abatement:** Licensee has submitted documentation to come into compliance with the continuing education requirements.

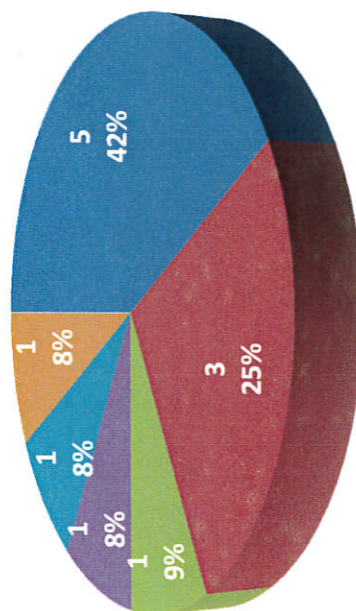

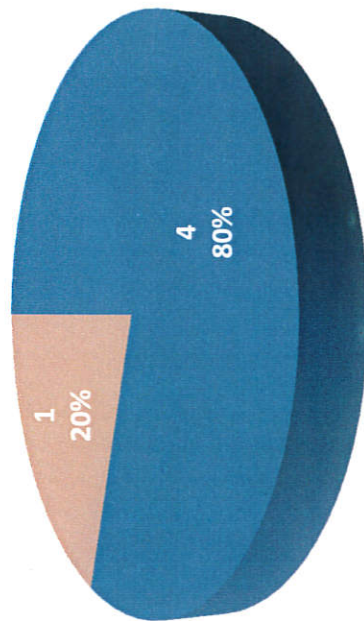

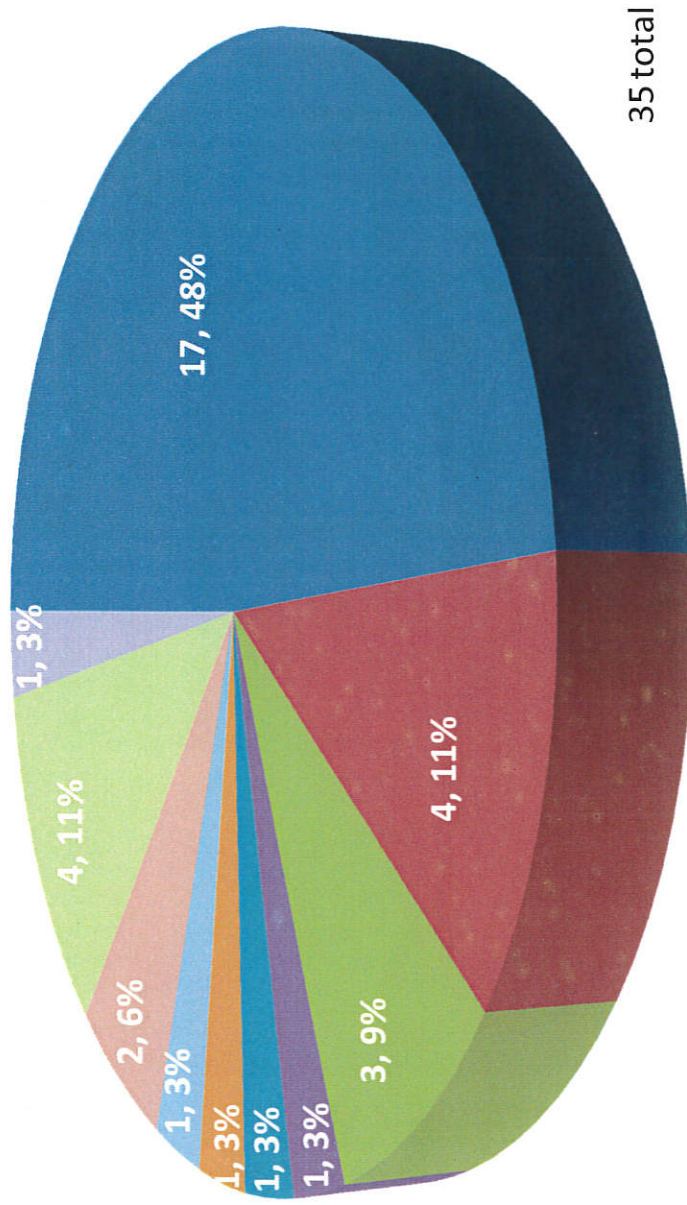
