Supervision Checklist

This checklist is to help supervisors understand the requirements regarding supervised professional experience (SPE) and is organized by the setting in which the trainee is gaining the experience. It is not a substitute for knowing the regulations in their entirety, but for convenience and to promote understanding of these complex regulations. As you review the checklist, please check the box for each requirement as it pertains to your setting.

<p>The primary supervisor is a licensed Psychologist. (1387.1 CCR).
