**Background:**

The Committee completed their review of all statutes and regulations affecting the pathways to licensure (i.e.: supervision requirements, psychological assistants, primary and delegated supervisor's responsibilities, out-of-state experience, etc.) at the March 2017 meeting.

After the March meeting, the Committee held two stakeholder meetings to review the proposed language. The first stakeholder meeting was held on May 4, 2017 in Sacramento, CA and the second stakeholder meeting was held on August 22, 2017 in Los Angeles, CA.

The Committee met to discuss the stakeholder's input during the meeting on October 13, 2017. The Committee will continue the review and make necessary changes at the meeting scheduled on January 22, 2018 with a goal to recommend the final proposed changes at the 2018 February Board Meeting.
