Attached please find the following Continuing Education (CE) Audit/Renewals for Psychologists and Psychological Assistants statistics (as of October 31, 2018):

Staff has completed CE audits through December 2016. The pass rate for the January 2016 – December 2016 CE audits was 82 percent. Among these audits, the fail rate was 18 percent with the primary reason for not passing the CE audit being not having the required 36 hours of CE.

The audit pass rate from 2014 through 2016 was 87 percent, with an average fail rate of 13 percent. For psychologists who have been audited a second time, the average pass rate was 68 percent and the average fail rate was 33 percent (note: statistics for second audits are from 2016).

An average of 1,244 Psychologist renewal applications were processed per month, with an average of 1,051 renewing as Active and 193 renewing as Inactive. Approximately 827 Psychologists renewed their license online per month and an average of 418 Psychologists mailed in their renewals.

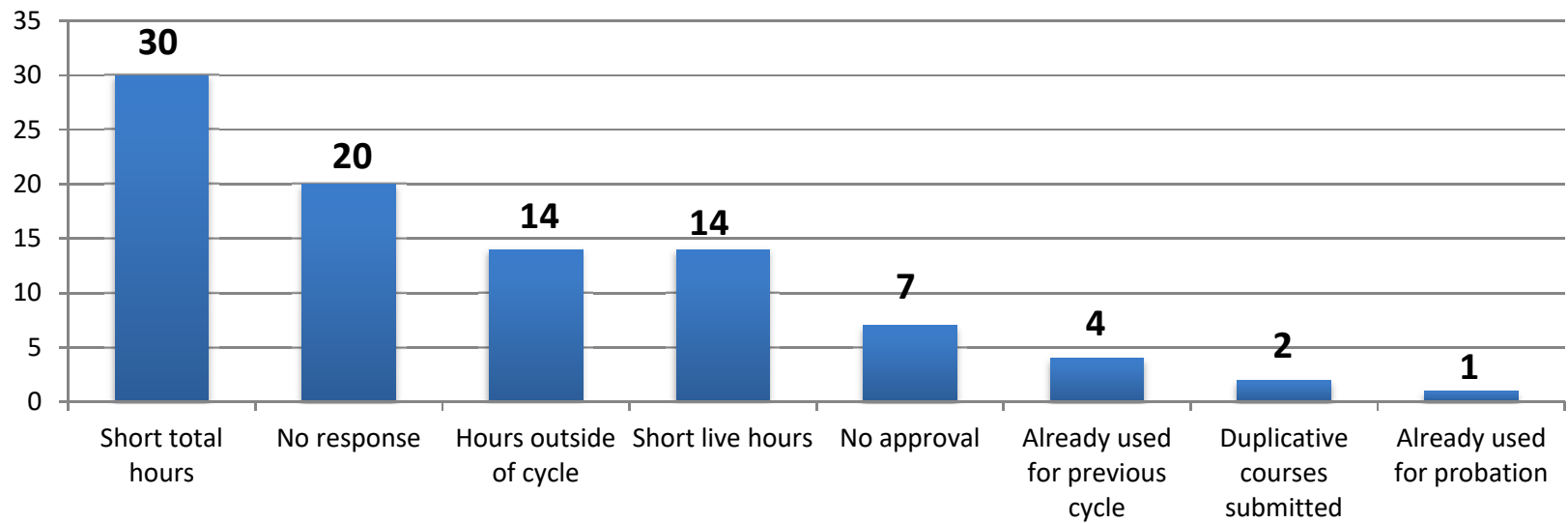

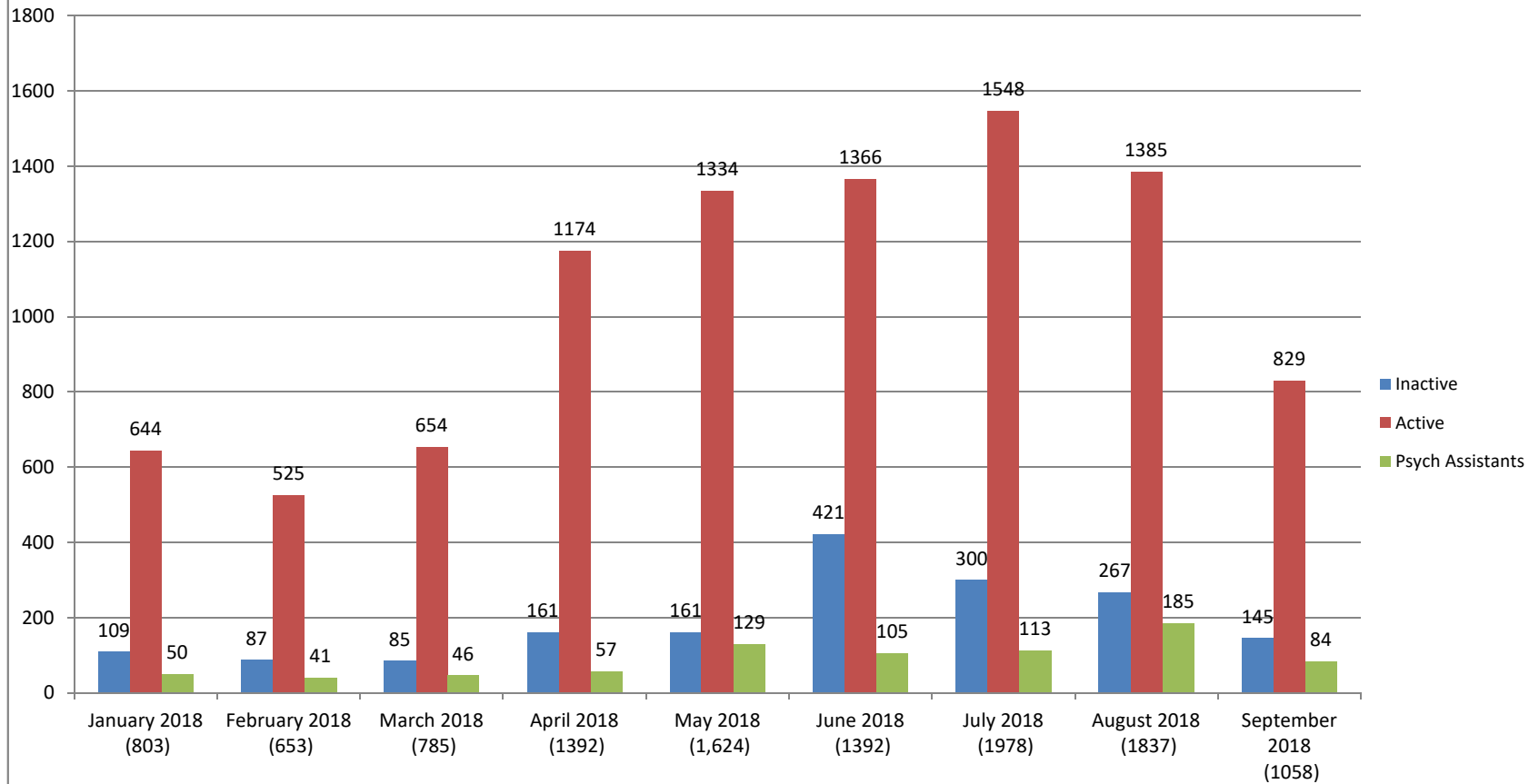

January - December 2016**

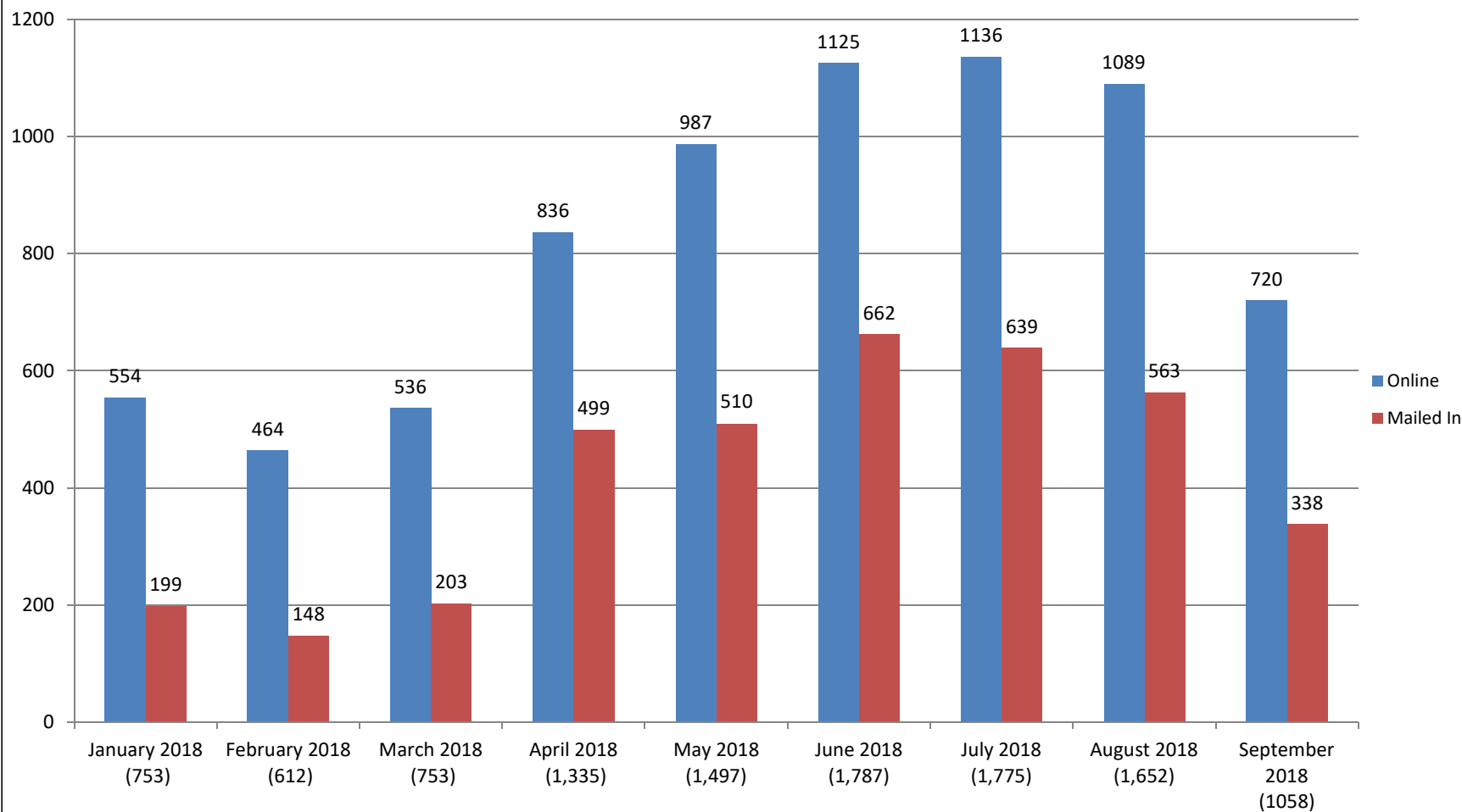


### Psychologist and Psychological Assistant Renewal Applications Processed January 2018 - September 2018



An average of 1,244 Psychologist renewal applications are processed each month, with an average of 1,051 renewing as Active and 193 renewing as Inactive. Additionally, an average of 90 Psychological Assistant renewal applications were processed each month.

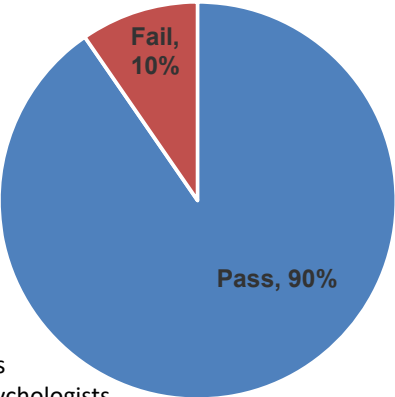
### Online vs. Mailed In Renewals Processed January 2018 - September 2018



On average, 827 Psychologists renew online per month and an average of 418 Psychologists mail in their renewals per month.

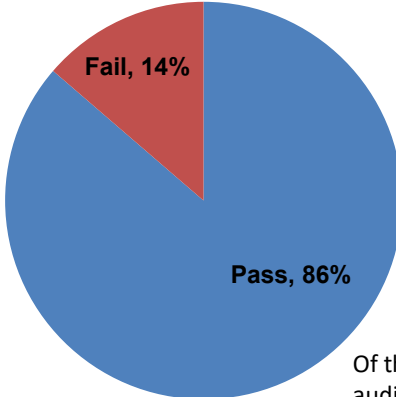
# Pass and Fail Rate 2014 - 2016

**2014**



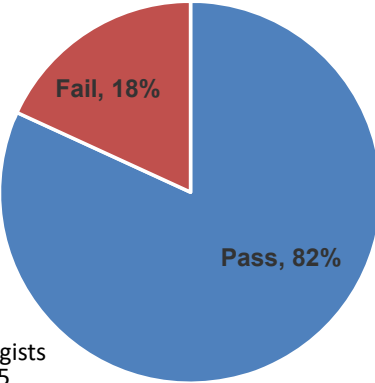
Of the 956 psychologists audited in 2014, 864 psychologists passed and 92 failed.
