49 **a. Proposed Amendments to Evidence Code § 1010 and the following Business and**
50 **Professions Code sections:**

67 Dr. Horn opened discussion of proposed changes to the following sections of the
68 statutes.

69
70 **Proposed Amendments to Business and Professions (B&P) Code § 2946 (Licensure in**
71 **Another State)**

72
73 The Committee discussed waiver of examination language in section 2946. Mr. Foo
74 recommended that the language remain in the statute since it is discretionary as to
75 whether the examination is waived. The Committee revisited this section after reviewing
76 the proposed language in regulations. Dr. Horn recommended to clarify in language that
77 the examinations are required, and all applicants are expected to take and pass the
78 examinations.

79
80 The Committee's changes were implemented as follows:

81
82 **§ 2946. Reciprocity licenses; Temporary practice by out-of-state licensees; Waiver**
83 **of examination requirement**

84
85 The board shall grant a license to any person who passes the board's supplemental
86 licensing examination and, at the time of application, has been licensed for at least
87 twofive years by a psychology licensing authority in another state or territory of the
88 United States or Canadian province if the requirements for obtaining a certificate or
89 license to practice psychology in that state, territory or province were substantially
90 equivalent to the requirements of this chapter.

91
92 A psychologist certified or licensed in another state, territory or province and ~~who~~ has
93 ~~made application~~ applied to the board for a license in this state may perform activities
94 and services of a psychological nature without a valid California license for a period not
95 to exceed 180 calendar days from the time of submitting his or her application or from
96 the commencement of residency in this state, whichever first occurs.

97
98 Applicants are expected to take and pass the required examinations. The board at its
99 discretion may waive the examinations, when in the judgment of the board the applicant
100 has already demonstrated competence in areas covered by the examinations. The board
101 at its discretion may waive the examinations for diplomates of the American Board of
102 Professional Psychology.

106 Proposed Amendments to B&P Code §§ 2909, 2909.5, 2910, & 2911 (Exemptions)

107
108 Dr. Horn pointed out that the proposed language in section 2911 should be edited to
109 separate pre-doctoral and post-doctoral trainees. Discussion ensued regarding the best
110 language to accomplish this. The Committee agreed to further simply the language in
111 section 2911 and their changes were implemented as follows:

112
113 **§ 2911. Applicability of chapter to ~~students and interns~~ (students, interns and**
114 **post-doctoral trainees)**

115
116 Nothing in this chapter shall be construed as restricting the activities and services of a
117 psychology graduate student or psychological intern in psychology pursuing a course of
118 study leading to a graduate degree in psychology at an accredited or approved college
119 or university and working in a training program, or a postdoctoral trainee working in a
120 postdoctoral placement overseen by the American Psychological Association (APA), the
121 Association of Psychology Postdoctoral and Internship Centers (APPIC), or the
122 California Psychology Internship Council (CAPIC), provided that these activities and
123 services constitute a part of his or her supervised course of study and that those persons
124 are designated by the title “psychological or psychology intern,” “psychological trainee,”
125 “postdoctoral intern,” or another title clearly indicating the training status appropriate to
126 his or her level of training. The aforementioned terms shall be reserved for persons
127 enrolled in the a doctoral program leading to one of the degrees that qualifies for
128 licensure listed in subdivision (b) of Section 2914(b) at an accredited or approved
129 college or university or a trainee in a formal pre-doctoral internship post-doctoral
130 placement overseen approved by the American Psychological Association (APA),
131 Association of Psychology Postdoctoral and Internship Centers (APPIC), or California
132 Psychology Internship Council (CAPIC).

133
134 *(Amended by Stats. 2005, Ch. 658, Sec. 3. Effective January 1, 2006.)*

135
136 Dr. Winkelman of CPA and Angela Gilliard, Legislative Director – UC Health from the
137 Office of the President of University of California, expressed concern regarding
138 proposed deletion of section 2910 and incorporation of some of its language into section
139 2909 because it prohibits professors from using the term “psychologist” in their official
140 titles. After discussion, Dr. Gilliard offered to draft language combining sections 2909
141 and 2910 and eliminating the problem for professors for the November 15-16, 2018
142 Board meeting. No changes to sections 2909 and 2910 were recommended by the
143 Committee and section 2909.5 was not discussed at the meeting.

147 Proposed Amendments to B&P Code § 2914 (Applicant Requirements)

148

149 Dr. Horn expressed concern that evaluations of foreign degrees performed by
150 evaluation services approved by the National Association of Credential Evaluation
151 Services (NACES) are not equivalent. She did not recommend amending section 2914
152 but suggested that the Board should consider specifying in regulation acceptable types
153 of NACES approved degrees in future.

154

155 Drs. Horn and Phillips pointed out that a degree should either be referenced as “a
156 doctorate” or “a doctoral degree”. After discussion, the Committee agreed that
157 “doctorate degree” be replaced with “doctoral degree” for clarity in this section.

158

159 The Committee’s changes were implemented as follows:

160

161 **§ 2914. Applicant’s requirements**

162

163 Each applicant for licensure shall ~~comply with all of the following requirements:~~

164

165 (a) ~~Is not~~ be subject to denial of licensure under Division 1.5 (commencing with Section
166 475).

167

168 (b) ~~P~~possess an earned ~~doctorate~~doctoral degree (1) in psychology, ~~(2) in educational~~
169 ~~psychology with the field of specialization in clinical, counseling, school, consulting,~~
170 ~~forensic or industrial/organizational psychology, or (3) in education with the field of~~
171 ~~specialization in counseling psychology, or educational psychology, or school~~
172 ~~psychology, or (3) in a field of specialization designed to prepare graduates for the~~
173 ~~professional practice of psychology.~~ Except as provided in subdivision (h), this degree or
174 training shall be obtained from an accredited university, college, or professional school.
175 The board shall make the final determination as to whether a degree meets the
176 requirements of this section.

177

178 (c) (1) On or after January 1, 2020, possess an earned ~~doctorate~~doctoral degree in
179 psychology, ~~in educational psychology with the field of specialization in clinical,~~
180 ~~counseling, school, consulting, forensic or industrial/organizational psychology,~~ or in
181 education with the field of specialization in counseling psychology, ~~or educational~~
182 ~~psychology, or school psychology~~ from a college or institution of higher education that is
183 accredited by a regional accrediting agency recognized by the United States Department
184 of Education. Until January 1, 2020, the board may accept an applicant who possesses
185 a ~~doctorate~~doctoral degree in psychology, ~~educational psychology with the field of~~
186 ~~specialization in clinical, counseling, school, consulting, forensic or~~
187 ~~industrial/organizational psychology,~~ or in education with the field of specialization in
188 counseling, ~~or educational psychology, or school psychology~~ from an institution that is
189 not accredited by an accrediting agency recognized by the United States Department of
190 Education, but is approved to operate in this state by the Bureau for Private
191 Postsecondary Education.

192

193 (2) Paragraph (1) does not apply to any student who was enrolled in a doctoral program
194 in psychology, ~~educational psychology with the field of specialization in clinical,~~
195 ~~counseling, school, consulting, forensic or industrial/organizational psychology,~~ or in
196 education with the field of specialization in counseling psychology, ~~or educational~~

197 psychology, or school psychology at a nationally accredited or approved institution as of
198 December 31, 2016.

199 ~~(3) No educational institution shall be denied recognition as an accredited academic~~
200 ~~institution solely because its program is not accredited by any professional organization~~
201 ~~of psychologists, and nothing in this chapter or in the administration of this chapter shall~~
202 ~~require the registration with the board by educational institutions of their departments of~~
203 ~~psychology or their doctoral programs in psychology.~~

204

205 (43) An applicant for licensure trained in an educational institution outside the United
206 States or Canada shall demonstrate to the satisfaction of the board that he or she
207 possesses a ~~doctorate~~doctoral degree in psychology or education pursuant to (c)(1) and
208 (2) that is equivalent to a degree earned from a regionally accredited academic
209 institution~~university~~ in the United States or Canada. These applicants shall provide the
210 board with a comprehensive evaluation of the degree performed by a foreign credential
211 evaluation service that is a member of the National Association of Credential Evaluation
212 Services (NACES), and any other documentation the board deems necessary.

213

214 (d) (1) ~~H~~have engaged for at least two years in supervised professional experience
215 under the direction of a licensed psychologist, the specific requirements of which shall be
216 defined by the board in its regulations, or under suitable alternative supervision as
217 determined by the board in regulations duly adopted under this chapter, at least one
218 year of which shall be occur after being awarded the qualifying doctoral degree~~doctorate~~
219 ~~in psychology~~. The supervisor shall submit verification of the experience ~~required by this~~
220 ~~subdivision to the trainee in a manner~~as prescribed by the board. If the supervising
221 licensed psychologist fails to provide verification to the trainee in a timely manner, the
222 board may establish alternative procedures for obtaining the necessary documentation.
223 Absent good cause, the failure of a supervising licensed psychologist to provide the
224 verification to the board upon request shall constitute unprofessional conduct.

225

226 (2) The board shall establish qualifications by regulation for supervising psychologists.

227

228 (e) ~~T~~take and pass the examination required by Section 2941 unless otherwise
229 exempted by the board under this chapter.

230

231 (f) ~~Show by evidence satisfactory to the board that he or she has completed~~
232 ~~training~~Complete coursework or provide evidence of training in the detection and
233 treatment of alcohol and other chemical substance dependency. ~~This requirement~~
234 ~~applies only to applicants who matriculate on or after September 1, 1985 as prescribed~~
235 by the board.

236

237 (g) (1) ~~Show by evidence satisfactory to the board that he or she has~~
238 ~~completed~~Complete coursework or provide evidence of training in spousal or partner
239 abuse assessment, detection, and intervention. ~~This requirement applies to applicants~~
240 ~~who began graduate training during the period commencing on January 1, 1995, and~~
241 ~~ending on December 31, 2003. as prescribed by the board.~~

242

243 (2) ~~An applicant who began graduate training on or after January 1, 2004, shall show by~~
244 ~~evidence satisfactory to the board that he or she has completed a minimum of 15 contact~~
245 ~~hours of coursework in spousal or partner abuse assessment, detection, and intervention~~
246 ~~strategies, including knowledge of community resources, cultural factors, and same~~

247 ~~gender abuse dynamics. An applicant may request an exemption from this requirement if~~
248 ~~he or she intends to practice in an area that does not include the direct provision of~~
249 ~~mental health services.~~

250
251 ~~(3) Coursework required under this subdivision may be satisfactory if taken either in~~
252 ~~fulfillment of other educational requirements for licensure or in a separate course. This~~
253 ~~requirement for coursework shall be satisfied by, and the board shall accept in~~
254 ~~satisfaction of the requirement, a certification from the chief academic officer of the~~
255 ~~educational institution from which the applicant graduated that the required coursework~~
256 ~~is included within the institution's required curriculum for graduation.~~

257
258 (h) Until January 1, 2020, an applicant holding a doctoral degree in psychology from an
259 approved institution is deemed to meet the requirements of this section if both of the
260 following are true:

261
262 (1) The approved institution offered a doctoral degree in psychology designed to prepare
263 students for a license to practice psychology and was approved by the former Bureau for
264 Private Postsecondary and Vocational Education on or before July 1, 1999.

265
266 (2) The approved institution has not, since July 1, 1999, had a new location, as
267 described in Section 94823.5 of the Education Code.

268
269 *(Amended by Stats. 2016, Ch. 484, Sec. 3. Effective January 1, 2017.)*

270
271 Proposed Amendments to B&P Code §§ 25, 28, 2915.5 (Training in Human Sexuality,
272 Child, Elder, and Dependent Adult Abuse Assessment and Reporting, and Aging and
273 Long-term Care), § 2915 (Continuing Professional Development), and §§ 29 & 2915.7
274 (Continuing Education: Chemical Dependency and Alcoholism and Aging and Long-
275 term Care)

276
277 Dr. Horn questioned whether to delete effective dates in section 2915.5. Dr. Elizabeth
278 Winkelman of the California Psychological Association (CPA) added that since the
279 modality to obtain and meet the pre-licensure course requirement is specified in the
280 proposed amendments in section 2915.5(d), the dates may not be necessary. The
281 Committee agreed.

282
283 Mr. Foo recommended deleting section 2915.7 and combining the requirements of that
284 section into section 2915.5 to avoid creating an unintentional dichotomy for licensees in
285 meeting this coursework requirement. Dr. Phillips also stated that since the potential
286 licensees would be able to meet this requirement through specific ways, such as
287 through a graduate training program or a continuing education course, he supported
288 amending the language that provides a uniform standard.

289
290 After discussion and input from Drs. Elizabeth Winkelman and Jo Linder-Crow of the
291 CPA, the Committee decided to delete dates in sections 2915 and 2915.5, delete
292 subsection 2915(d)(1), delete section 2915.7 and combine requirements of that section
293 into section 2915.5.

294
295 Sections 25, 28, and 29 were not discussed by the Committee.

296

297 The Committee's changes were implemented as follows:

298
299 **§ 2915. Continuing education requirements; Practice outside fields of competence**

300
301 (a) Except as provided in this section, the board shall issue a renewal license only to an
302 applicant licensed psychologist who has completed 36 hours of approved continuing
303 professional development in the preceding two years.

304
305 (b) ~~A~~Each person licensed psychologist who ~~applies to~~ renews or reinstates his or her
306 license issued pursuant to this chapter shall certify ~~under penalty of perjury that he or~~
307 ~~she is in~~ compliance with this section under penalty of perjury, and shall retain proof of
308 this compliance for submission to the board upon request. False statements submitted
309 pursuant to this section shall be a violation of Section 2970.

310
311 (c) Continuing professional development means certain ~~continuing education~~ learning
312 activities approved in four different categories:

313
314 (1) Professional Activities.

315
316 (2) Academic Activities.

317
318 (3) Sponsored eContinuing eEducation eCoursework.

319
320 (4) Board eCertification from the American Board of Professional Psychology.

321
322 The board may develop regulations further defining acceptable continuing professional
323 development activities.

324
325 ~~(d) (1) The board shall require a licensed psychologist who began graduate study prior to~~
326 ~~January 1, 2004, to take a continuing education course during his or her first renewal~~
327 ~~period after the operative date of this section in spousal or partner abuse assessment,~~
328 ~~detection, and intervention strategies, including community resources, cultural factors,~~
329 ~~and same gender abuse dynamics. Equivalent courses in spousal or partner abuse~~
330 ~~assessment, detection, and intervention strategies taken prior to the operative date of~~
331 ~~this section or proof of equivalent teaching or practice experience may be submitted to~~
332 ~~the board and at its discretion, may be accepted in satisfaction of this requirement.~~

333
334 ~~(2) Continuing education courses taken pursuant to this subdivision shall be applied to~~
335 ~~the 36 hours of approved continuing professional development required under~~
336 ~~subdivision (a).~~

337
338 (e) Continuing education courses approved to meet the requirements of this section shall
339 be approved for credit by organizations approved by the board. An organization
340 previously approved by the board to provide or approve continuing education is deemed
341 approved under this section.

342
343 (f) The board may accept continuing education courses approved by an entity that has
344 demonstrated to the board in writing that it has, at a minimum, a 10-year history of
345 providing educational programming for psychologists and has documented procedures

346 for maintaining a continuing education approval program. The board shall adopt
347 regulations necessary for implementing this section.

348
349 ~~(g) The board may grant an exemption, or an extension of the time for compliance with,~~
350 ~~from the continuing professional development requirement of this section.~~

351
352 ~~(gh)~~ The administration of this section may be funded through professional license fees
353 and continuing education provider and course approval fees, or both. The fees related to
354 the administration of this section shall not exceed the costs of administering the
355 corresponding provisions of this section.

356

359 **§ 2915.5. Coursework in aging and long-term care required for licensure of new**
360 **applicant; Instruction on assessment and reporting of, as well as treatment related**
361 **to, elder and dependent adult abuse and neglect**

362
363 (a) Any applicant for licensure as a psychologist ~~who began graduate study on or after~~
364 ~~January 1, 2004,~~ shall complete, as a condition of licensure, a minimum of ~~40~~six (6)
365 ~~contact~~ hours of coursework or applied experience in aging and long-term care, which
366 may include, but need not be limited to, the biological, social, and psychological aspects
367 of aging. ~~On and after January 1, 2012,~~This coursework shall include instruction on the
368 assessment and reporting of, as well as treatment related to, elder and dependent adult
369 abuse and neglect.

370
371 ~~(b) Coursework taken in fulfillment of other educational requirements for licensure~~
372 ~~pursuant to this chapter, or in a separate course of study, may, at the discretion of the~~
373 ~~board, fulfill the requirements of this section.~~

374
375 ~~(eb)~~ In order to satisfy the coursework requirement of this section, the applicant shall
376 submit to the board a written certification from the registrar or training director~~chief~~
377 ~~academic officer~~ of the educational institution or program from which the applicant
378 graduated stating that the coursework required by this section is included within the
379 institution's required curriculum for graduation at the time the applicant graduated, or
380 within the coursework, that was completed by the applicant.

381
382 ~~(c)~~ If an applicant does not have coursework pursuant to this section, evidence of
383 compliance can be obtained as part of his or her applied experience. Applied
384 experience can be met in any of the following settings: practicum, internship, or formal
385 postdoctoral placement that meets the requirement of Section 2911, or other qualifying
386 supervised professional experience. To satisfy this requirement, the applicant shall
387 submit to the board a written certification from the director of training for the program or
388 primary supervisor where the qualifying experience has occurred stating that the training
389 required by this section is included within the applied experience.

390
391 ~~(d)~~ If an applicant does not meet the curriculum or coursework requirement pursuant to
392 this section, evidence of compliance can be obtained by taking a continuing education
393 course that meets the requirements of subdivision (e) or (f) of Section 2915 and that
394 qualifies as a continuing education learning activity category specified in paragraph (2)
395 or (3) of subdivision (c) of Section 2915. To satisfy this requirement, the applicant shall

396 submit to the board a certification of completion~~The board shall not issue a license to the~~
397 ~~applicant until the applicant has met the requirements of this section.~~

405 ~~(a) A licensee who began graduate study prior to January 1, 2004, shall complete a~~
406 ~~three-hour continuing education course in aging and long-term care during his or her first~~
407 ~~renewal period after the operative date of this section, and shall submit to the board~~
408 ~~evidence acceptable to the board of the person's satisfactory completion of that course.~~

409
410 ~~(b) The course should include, but is not limited to, the biological, social, and~~
411 ~~psychological aspects of aging. On and after January 1, 2012, this coursework shall~~
412 ~~include instruction on the assessment and reporting of, as well as treatment related to,~~
413 ~~elder and dependent adult abuse and neglect.~~

414
415 ~~(c) Any person seeking to meet the requirements of subdivision (a) of this section may~~
416 ~~submit to the board a certificate evidencing completion of equivalent courses in aging~~
417 ~~and long-term care taken prior to the operative date of this section, or proof of equivalent~~
418 ~~teaching or practice experience. The board, in its discretion, may accept that certification~~
419 ~~as meeting the requirements of this section.~~

420
421 ~~(d) The board may not renew an applicant's license until the applicant has met the~~
422 ~~requirements of this section.~~

423
424 ~~(e) A licensee whose practice does not include the direct provision of mental health~~
425 ~~services may apply to the board for an exception to the requirements of this section.~~

429 Proposed Amendments to B&P Code § 27 (Disclosure of Information), § 2903
430 (Licensure Requirements), § 2913 (Psychological Assistant), §§ 2940 & 2941
431 (Application and Examination Fees), §§ 2942, 2943, & 2944 (Examination Time and
432 Subjects), § 2948 (Issuance of License), and § 2960 (Grounds for Disciplinary Action)

433
434 These sections were not discussed by the Committee.

435
436 Dr. Winkelman questioned whether the time allowed for temporary practice by a
437 licensee of another state or country is consecutive or total time as stated in B&P Code
438 section 2912. The Committee could not discuss the specific section because it was not
439 on the agenda. The Committee recommend including the section on the agenda for the
440 next Licensing Committee meeting.

441
442 It was M(Foo)/S(Phillips) to approve the language as amended and move the pathway
443 statutory amendments for the full Board's consideration and proceed to legislation.

445 There was no public comment.

Dr. Horn opened discussion of proposed changes to the following sections of the regulations.

Proposed Amendments to Title 16 of the California Code of Regulations (CCR) § 1380.3 (Definitions)

Mr. Foo expressed concern of the definition of “he or she” in section 1380.3(c) as it is not representative of the applicable community. After discussion, the Committee agreed that “he or she” in subsection (c) be replaced with “applicant,” “licensee,” “trainee” etc. as appropriate throughout the proposed regulation amendments and removed it from this section.

Dr. Winkelman suggested that the definition of General Applied Psychology be added to the section 1380.3 because she found that in reading through the changes to the supervision requirements and the introduction to the term General Applied Psychology, it was confusing, and it would be helpful to define it in this section. Dr. Horn agreed and suggested that the definition of Health Service Psychologist also be added to the definitions in section 1380.3. The Committee discussed definition language and their changes were implemented as follows:

§ 1380.3. Definitions.

Dr. Winkelman, CPA, and Dr. Marilyn Immoos, Department of Corrections and Rehabilitation, questioned whether the proposed language in section 1387.5(9), which was renumbered from (5) from the existing language, requires that the weekly log be signed by the supervisor each week. After discussion, the Committee decided to delete subsection (9). The Committee also agreed that in the future, the Board should draft a sample weekly log.

1612 Educational Testing Service directly to the Board. The TOEFL must have been taken

1615 applicant will be allotted time-and-a-half (1.5x) when taking the examination.

Agenda Item #5: Psychological Assistant's Inactive Status: Review Proposed Amendments to Business and Professions Code Section 2987 and Title 16 of the California Code of Regulations Sections 1391.11, 1391.12, 1391.13, 1391.14, and 1392.1.

Ms. Cheung explained that at the April 2018 Committee meeting, concern was raised regarding psychological assistants who are not able to practice or be active during the shortened maximum registration period which was changed from seventy-two to sixty months pursuant to the proposed regulatory amendments for Pathways to Licensure.

The Committee discussed establishing an inactive status for psychological assistants with input from Dr. Winkelman.

Proposed Amendments to Business and Professions Code Section 2987 as written:

§ 2987. Fee schedule

The amount of the fees prescribed by this chapter shall be determined by the board, and shall be as follows:

- (a) The application fee for a psychologist shall not be more than fifty dollars (\$50).
- (b) The examination and reexamination fees for the examinations shall be the actual cost to the board of developing, purchasing, and grading of each examination, plus the actual cost to the board of administering each examination.
- (c) The initial license fee is an amount equal to the renewal fee in effect on the last regular renewal date before the date on which the license is issued.
- (d) The biennial renewal fee for a psychologist shall be four hundred dollars (\$400). The board may increase the renewal fee to an amount not to exceed five hundred dollars (\$500).
- (e) The application fee for registration as a psychological assistant under Section 2913 shall not be more than seventy-five dollars (\$75).
- (f) The annual renewal fee for registration of a psychological assistant shall not be more than seventy-five dollars (\$75).
- (g) The duplicate license or registration fee is five dollars (\$5).
- (h) The delinquency fee is 50 percent of the renewal fee for each license type, not to exceed one hundred fifty dollars (\$150).
- (i) The endorsement fee is five dollars (\$5).
