SUBJECT	Enforcement Report, Agenda Item 19	

Enforcement Staff

In December 2018, two Enforcement Analysts (Associate Governmental Program Analysts) left the Board of Psychology. One retired and the other accepted a promotion with another board within the Department of Consumer Affairs. Consequently, the Board is actively looking to recruit two new Enforcement Analysts. Interviews are currently being held in anticipation of filling both positions within the next several weeks. The Enforcement Analysts are responsible for analyzing consumer complaints, performing desk investigations, referring cases for formal investigation, reviewing Accusations and negotiating Stipulated Settlements with the Office of the Attorney General.

Complaint Program

Since July 1, 2018, the Board has received 638 complaints. Complaints can be submitted on-line, via fax, telephonically, or mailed to the Board. All complaints received are opened and assigned to an enforcement analyst. On average, the intake process is completed within five (5) days of receipt of the complaint.

Citation Program

Since July 1, 2018, the Board has issued 40 enforcement citations. Citation and fines are issued for some probation violations and minor violations that do not require formal discipline. For example, false or misleading advertising and minor record keeping violations are considered minor violations.

Discipline Program

Since July 1, 2018, the Board has referred 27 cases to the Office of the Attorney General for formal discipline.

Probation Program

Enforcement staff is currently monitoring 41 active probationers and 23 tolled probationers. Active monitoring is ensuring that each probationer is complying with each of the terms and conditions of probation which includes meeting with each new probationer at the onset of probation to discuss all of the terms and conditions of their probation, discussing the status of probation and providing early termination information, conducting a quarterly audit of each probation file, and answering questions from probationers.

Of the 41 probationers, nine (9) have had probation violations. If a probationer is out of compliance, the Board may issue a citation and fine or refer the matter to the Office of the Attorney General for further discipline of their license. For minor violations, the probationer will most likely be issued a citation and fine which can include an Order of Abatement to correct the non-compliance. For more egregious violations, or accumulation of minor violations, the case would be referred to the Office of the Attorney General for possible revocation or an extension of probation.
