## Background:

In February, 2015, Assembly Member Garcia requested an opinion from the Attorney General (AG) regarding mandatory reporting requirements under CANRA, on behalf of the Board of Psychology. Since then, the issue became subject to litigation. The Board was notified that the opinion was on hold pending the case.

As of June 2016, the Board's request was canceled (Canceled Opinion Request #15-201 – Eisenberg). Attached is the Board's request for information to determine the reason for the opinion's cancelation.


